and forty nine, between Allen Anderson of the one part, and Levi Morris of the other

Dollars in hand paid by the said Levi Morris the receipt and payment I do hereby
acknowledge hath granted bargained and sold and by these presents do grant bargain
and sell to the said Levi Morris his heirs and assigns a tract of land situated in the County
of Craven on the North side of Neuse river, bounded as follows, beginning at a pine Jacob
Tousens beginning corner on the side of the Bay Bush by a warrens granted to Joseph
James N^o 357. issued the 12th day of March 1787. thence running South fifty East, one
hundred and ten pole to a pine thence fifty seven degrees East, one hundred pole
thence South ten degrees East to the Bear hole swamp thence up the various courses
the same to Tousens line thence with the same to the first station containing fifty acres
be the same more or less, To have and to hold the same to the said Levi Morris his heirs
and assigns forever, And I the said Allen Anderson and my heirs do covenant, and
agree to and witness the said Levi Morris his heirs and assigns that I have a good
right and absolute and full authority to grant, bargain and sell the premises hereby
granted, bargained and sold in fee simple that the said premises are free and clear
of claims of myself or my heirs or all persons claiming under me or my heirs, In
