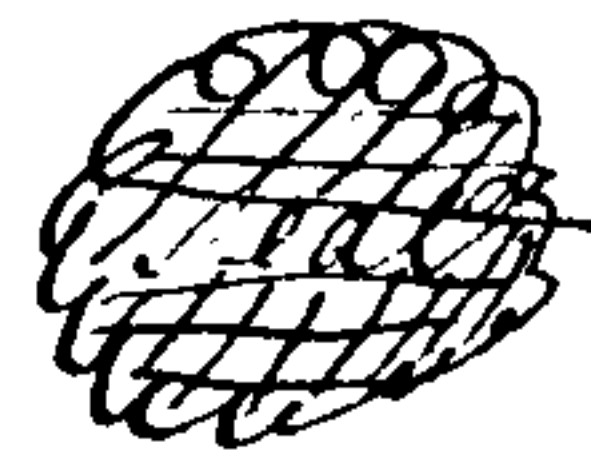

Consideration of the sum of fifteen Pounds Shew to him
the said John Anderson in Hand paid by the said Jonas
Anderson the Receipt whereof the said John Anderson
doth hereby Acknowledge to be therewith fully satisfied
& paid & thereof both Acquitted & Discharge the said Jonas
Anderson his heirs & Assigns for ever have Granted
Bargained & Sold Alind Conveyed & Confirmed unto the
said Jonas Anderson his heirs & Assigns for ever all
that Plantation tract or parcel of Land containing by
Estimation Twenty Acres lying in Craven County
in the state of North Carolina on the South side
